
2. Terms and conditions:

- 2.1 The period to spent for Deputation/ Programme/ Course, including transit, will be treated as on duty;
 - 2.2 They will draw their usual pay and allowances from Bangladesh in local currency;
 - 2.3 All expenses in connection with the Programme will be borne by PEDP-3 of the Ministry of Primary and Mass Education.
 - 2.4 They will not be allowed to stay abroad more than the above period;
 - 2.5 They must execute a bond in a prescribed form against the total sanctioned amount before departure from Bangladesh;
 - 2.6 They must sign a contract individually declaring that after completion of the course they will work at least 10 years under the Ministry of Primary and Mass Education (MoPME);
 - 2.7 They will leave Dhaka for UK on 04 March 2018 or nearest possible date and will leave UK for Bangladesh on 01 March 2019 or nearest possible date;
 - 2.8 On return from abroad, they will report to their present place of posting and submit a complete report as well as Individual Action Plan (IAP) to the Ministry and other concerned within 15 days..
