- (a) While on deputation, she will be treated as on duty;
- (b) She will draw her pay and allowances in local currency. No part of it should be drawn in foreign currency;
- (c) All expenses to be incurred as to the course tuition fees and living cost will be borne by the University of Oslo, Norway and Rotary Club of Albuquerque Del Sol.
- (d) After completion the study she will must return to the country and will have to submit a report to the Ministry. She will have to submit her certificate within one year after completion of her study.
- (e) She will have to join her service after completion of her study.
- (f) She will not be allowed to stay more than the approved period.
- (g) She must sign and submit an undertaking in non-judicial stamp above 300/- (Three hundred) taka declaring that after completion of the course, she will work at least 02 (two) years under the Ministry of Primary and Mass Education. Otherwise pay and allowance to be taken during deputation period will be refund from her under the Public Demands Recovery Act, 1913.
- (h) She will be attached to District Primary Education Office (DPEO), Dhaka as Officer On Special Duty (OSD) during deputation period.
