
**2. Terms and conditions:**

- 2.1 The period to spent for deputation/programme/course, including transit, will be treated as on duty;
  - 2.2 They will draw their usual pay and allowances from Bangladesh in local currency;
  - 2.3 Total Tk 29,05,760.00 (Twenty nine lac five thousand seven hundred and sixty taka) (of which 11,66,000.00 taka for tuition fee; 13,39,800.00 taka for Living Cost; 1,70,710.00 taka for establishment allowance; 1,43,000.00 taka for Air fair (round trip); 38,500.00 taka for VISA fee; 25,850.00 taka for Medical Insurance and 22,000.00 taka for thesis research) will be provided to the individual candidate for the masters program from PEDP-3.
  - 2.4 They will not be allowed to stay abroad more than the above period;
  - 2.5 They must execute a bond in a prescribed form against the total sanctioned amount before departure from Bangladesh;
  - 2.6 They must sign a contract individually declaring that after completion of the course they will work at least 10 years under the Ministry of Primary and Mass Education (MoPME);
  - 2.7 They will leave Dhaka for UK on 13 November 2016 or a date close to that and will leave UK for Bangladesh on 21 November 2017 or a date close to that;
  - 2.8 On return from abroad, they will be report to their present place of posting and submit a complete report as well as Individual Action Plan (IAP) to the Ministry and other concern within 15 days..
