**2. Terms and conditions:**

- 2.1 The period to spent for Deputation/ Programme/ Course, including transit, will be treated as on duty;
  - 2.2 They will draw their usual pay and allowances from Bangladesh in local currency;
  - 2.3 All expenses in connection with the Programme will be borne by PEDP-3 of the Ministry of Primary and Mass Education.
  - 2.4 Total amount of money (in British pound sterling) for tuition fee £11,250.00, living cost £9,135.00, establishment allowance (book, stationary, Laptop, Study tour, internet etc.) £1,500.00, air fare (round trip) £1,300.00, Visa fee £350.00, medical insurance £235.00 and thesis research £200.00 total £23,970.00 British pound will be provided for the Masters programme per person.
  - 2.5 They will not be allowed to stay abroad more than the above period;
  - 2.6 They must execute a bond in a prescribed form against the total sanctioned amount before departure from Bangladesh;
  - 2.7 They must sign a contract individually declaring that after completion of the course they will work at least 10 years under the Ministry of Primary and Mass Education (MoPME);
  - 2.8 They will leave Dhaka for UK on 07 February 2017 or nearest possible date and will leave UK for Bangladesh on 08 February 2018 or nearest possible date;
  - 2.9 On return from abroad, they will report to their present place of posting and submit a complete report as well as Individual Action Plan (IAP) to the Ministry and other concerned within 15 days..
